# **TERMS & CONDITIONS**

PAYMENT TERMS: Handy Distribution's terms are net 10<sup>th</sup> proximo. As an example, purchases during the current month are due net the 10<sup>th</sup> of next month. An account which goes out of terms may be placed on credit hold at Handy Distribution's discretion until the account is brought back within terms. Applicant must notify Handy Distribution of billing errors or adjustments in writing within ten (10) days from the invoice date. Claims not received in writing within the time specified are waived by Applicant.

<u>VARIABLE COSTS</u>: The quoted price for the products/services listed on a sales acknowledgment and/or proforma are exclusive of any and all applicable tariffs, duties, or taxes unless expressly stated otherwise. It is Buyer's sole and absolute responsibility to cover any variable costs, including, without limitation, tariffs, duties, taxes, and/or surcharges, applied and/or assessed against the products/services.

NON-REFUNDABLE DEPOSIT: Buyer's deposit shall become non-refundable if Buyer cancels an order for products/services after Seller has initiated work on the same, including, without limitation, the ordering of materials, parts, and equipment.

## LIMITED MODIFICATION:

No modifications of terms or conditions by the customer different from the above terms will become part of any sales agreement, purchase order, or other documents and will not be enforceable unless specifically approved in writing by Handy Distribution's Director of Corporate Credit.

#### LATE CHARGES:

A late payment charge of 1% per month (12% annually) may be applied to each invoice that goes past due and then each month thereafter until paid.

## **TERMS & CONDITIONS (Continued)**

#### CONTINUATION OF CREDIT APPLICATION (HANDY DISTRIBUTION):

Customer agrees to provide annual financial statements and updated credit application each year as a condition for the continuation of credit.

## CHANGE OF NAME, LEGAL STATUS OR OWNERSHIP:

Applicant agrees to promptly notify by writing via mail or email any change in applicant's legal name, legal status or ownership under which credit is established.

IN THE EVENT OF DEFAULT:
The customer is responsible for all collection costs incurred by Handy Distribution in collecting amounts owed to Handy Distribution under customer's open account, including all legal/collection fees. Customer also agrees that any legal action to collect sums due under open account may be taken in the City of Lynchburg, Virginia, at Handy Distribution option, and to waive the right to a jury trial on any issue.

All Electronic, Facsimile, and Stamped signatures shall be deemed original signatures for all purposes in connection herewith.
